Open Government Training Handout

Open Government Training. Sections 551.005 and 552.012, Texas Government Code, require elected and appointed officials who are members of governmental bodies that are subject to the Texas Open Meetings Act or the Texas Public Information Act to take open government training:

- Officials who are members of a governmental body subject to the Open Meetings Act must take **one hour** of training on the **Open Meetings Act**.
- Officials, who are members of governmental bodies subject to the Public Information Act, must take **one hour** of training on **Open Records**, or they can designate the governmental body's public information coordinator to be trained on their behalf.

Although there may be some question as to the applicability of this new law to advisory committees, as a precautionary measure, we recommend that all board/committee members complete the training. This is a one-time training requirement.

Compliance Deadline. The deadline for newly appointed board and committee members is not later than the 90th day after the date the member assumes responsibilities as a member of the governmental body. Tex. Gov't Code Ann. §§ 551.005(a), 552.012(b).

Training Availability. The Attorney General has made training available at no charge on its website at: <u>https://www.texasattorneygeneral.gov/og/open-government-training</u> Public officials can go to this website, then click on "Open Meetings Act training video" or "Public Information Act training video" to view the training video and then obtain a course completion certificate for viewing the training.

Designation of Public Information Coordinator to Receive Open Records Training. The Open Records portion of the new law allows public officials the **option to designate a public information coordinator (PIC)** to attend training **in their place** so long as the designee is the person primarily responsible for the processing of open records requests for their governmental body. A designation letter is attached for your signature if desired. Please sign the designation letter and submit a copy to the Comptroller's Office.

Evidence of Course Completion. The governmental body must "maintain and make available for public inspection the record of its members' completion of the training." Tex. Gov't Code Ann. § 551.005(c); § 552.012(e). Please submit a copy of your Open Meeting training certificate and your Open Records designation letter to: **Texas Comptroller of Public Accounts, Attn: Broadband Development Office Board of Advisors, Data Analysis and Transparency Division, Post Office Box 13528, Capitol Station, Austin, Texas 78711-3528.**

Board of Advisors Roles and Responsibilities

The Broadband Development Office (BDO) is statutorily authorized through Texas Government Code Chapter 490I, and is housed within the Comptroller of Public Accounts (agency). The Board of Advisors (advisory board) is created in Section 490I.0110, and is made up of eight appointed members, the Comptroller or his designee (who serves as the chair), and a nonvoting member appointed by the BDO. Meetings of the advisory board are open meetings subject to Chapter 551. The board is required to meet at least monthly until June 15, 2022, then at least every other month at the call of the chair.

The duties and roles of the advisory board are authorized under Sections 490I.0110(g) and (j) as follows:

(g) The board of advisors shall provide guidance to the broadband development office regarding the expansion, adoption, affordability, and use of broadband service and the programs administered by the office.

(*j*) The board of advisors may consult with stakeholders with technical expertise in the area of broadband and telecommunication technology.

The advisory board is a structured and collaborative way for BDO to engage with external advisors. The advisory board can act as a sounding board to allow BDO to test their strategic thinking and access expertise or connections that may not be readily available via other means.

Purpose and Role:

- to help BDO gain value-driven insights and background, focus input, provide nonbinding advice to solve problems, and to increase organizational impact
- to contribute their experience and respective areas of expertise. This can provide BDO insights into the potential implications of various strategies and decisions
- to actively contribute to the goals and desired outcomes defined by BDO
- to provide current knowledge, critical thinking and analysis to improve program effectiveness, incorporate best practices, and increase the confidence of the decision makers
- to foresee and identify obstacles or pitfalls of the current path, and identify strategic changes to improve organizational trajectory
- can provide safe harbors to 'test drive' options before they become more definitive
- to explore new opportunities by stimulating robust, high-value conversations
- to assist with short-term and long-term planning
- to serve as advocates and allies for BDO and create strategic introductions within approved guidelines for BDO

Advisory board members are not authorized to make decisions or speak on behalf of the agency or BDO. Additionally, advisory board members are required to acknowledge and abide by BDO's "Ethical Standards of Conduct."

- American Rescue Plan Act (March 2021)
 - Coronavirus State and Local Fiscal Recovery Fund
 - Coronavirus Capital Projects Fund
- Infrastructure Investment and Jobs Act (Nov 2021)
 - Broadband Equity, Access, and Deployment
 - Digital Equity Act
 - Middle Mile
 - Affordability
- State Revenue



Summary of current and future funding opportunities for BDO (cont.)

- Coronavirus Capital Projects Fund (US Treasury)
 - Texas was allotted \$500.4 million
 - \$75 million broadband pole replacement program
 - "to carry out critical capital projects directly enabling work, education, and health monitoring, including remote options, in response to the public health emergency."
 - 100 Mbps symmetrical
 - No "unserved"/"underserved" requirement



Summary of current and future funding opportunities for BDO (cont.)

- Infrastructure Investment and Jobs Act
 - Broadband Equity, Access, and Deployment (NTIA)
 - \$42.5 billion nationwide, \$100 million per state
 - Purpose: Address availability
 - Cascading use of funds
 - Pending FCC new maps
 - Digital Equity Act (NTIA)
 - \$2.75 billion nationwide
 - Purpose: Support overlooked and underserved areas

1. Unserved (< 25/3 Mbps)

→2. Underserved (< 100/20 Mbps)

→ 3. Community anchor institutions



Deadlines for HB 5 (87R) and the Capital Projects Fund (CPF)

- HB 5
 - State Broadband Plan: June 15th
 - Federally Compliant Grant Program
 - State Broadband Availability Map: Jan 1, 2023
- Capital Project Funds (Treasury)
 - Grant Plans: Sept. 24, 2022
 - Funding expended by Dec. 31, 2026




Next steps for broadband funding related to the Infrastructure Investment and Jobs Act

- NTIA to release NOFO May 16, 2022
 - Each state to receive \$100 million minimum
 - Total amount allocated to Texas still unknown
- States need to develop and submit:
 - 5-year action plan for infrastructure
 - Statewide Digital Equity Plan

State Broadband Plan

- HB 5 requires the BDO to prepare, update and publish a statewide plan to serve as a strategic guide to close the digital divide in Texas (deadline June 15, 2022)
- Plan will establish long-term goals for:
 - greater access to and adoption of broadband services
 - affordability of broadband services
 - use of broadband services



State Broadband Plan (cont)

- BDO is collecting stakeholder feedback through a combination of:
 - townhalls (Broadband Listening Tour);
 - round table discussions;
 - direct outreach; and
 - broadband surveys.
